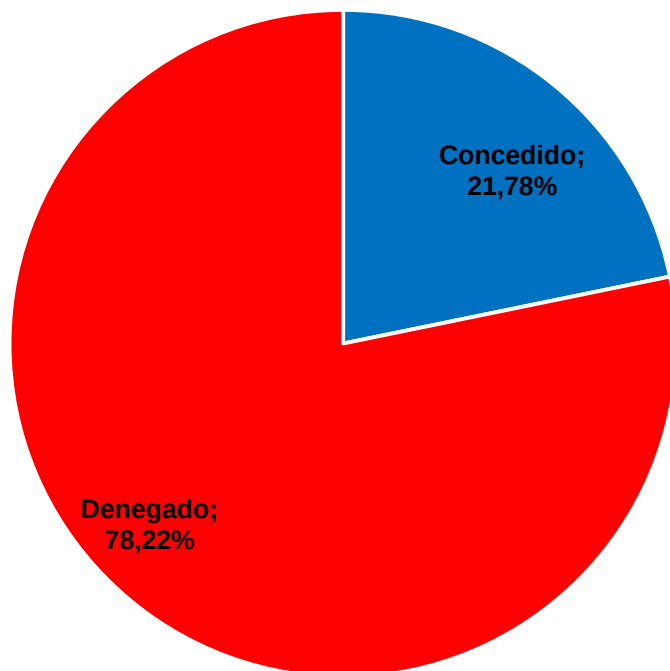

\* Os cálculos foram realizados desconsiderando os HC's prejudicados e indeferidos liminarmente.

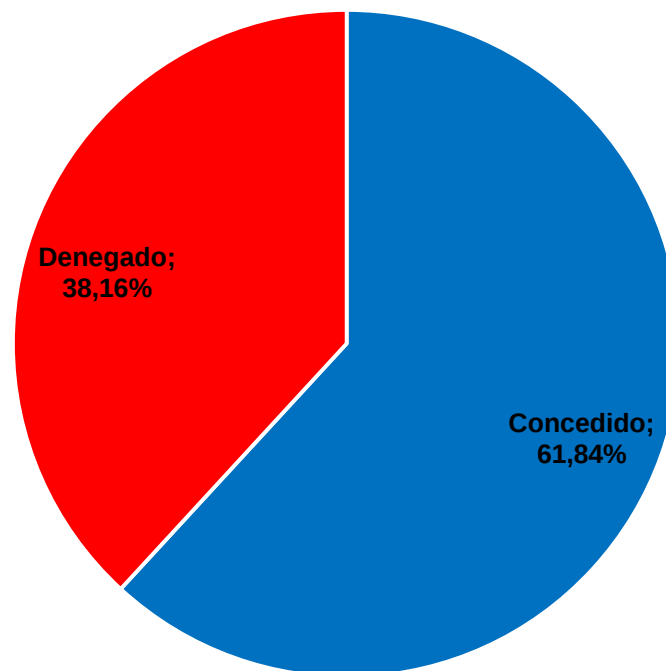
